FOR PREPARING PAPERS FOR PUBLICATION IN THE MONOGRAPH

**“TERRITORIAL CONCISENESS AND TERRITORIAL IDENTITY IN CENTRAL, EASTERN
AND SOUTH-EASTERN EUROPE”**

The main aim of the preparing monograph is to present the ideas and investigations of the scholars from Central, Eastern and South-Eastern Europe which specialize in the subjects such as conciseness and identity of different social groups in the spatial scale. Among the authors will be representants of the human geography, ethnology, philology, sociology and other scientific disciplines.

The main directions of the planning publication are as follows:

Theoretical and methodological aspects of the territorial conciseness and territorial identity

Territorial identity as a subject of science, politics and ideology

The categories “ethnic territory”, “state territory” and “historical territory” in the conciseness of the national and ethnic communities

The identity of the separate regions and its contemporary geocultural, geoeconomic and geopolitical importance

The identity of multiethnic and multicultural territorial communities

The supranational territorial conciseness and territorial identity

The identity and territorial symbols of the cities

The regional identity as a basis for development of tourism

The main text, tables, figures, illustrations

Papers must be submitted in WORD format.

Font: Times New Roman.

Font size: 12.

Line spacing 1,5.

The main elements of the paper: *title page* which must consist of the title of the paper (Times New Roman – 14), the name and surname of the Author/s, Author’s affiliations and contact data: Institution, the scientific and academic degree, e-mail address; *text* of the paper; *references*. The tables, maps and graphics should be included in the text. The figures should be marked as “Fig.” and numbered and titled too (Fig. 1 The spatial levels of identity of the Romanians).

Minimal size of the paper – 10 pages (with references, tables, maps and graphics).

The entire paper should not exceed 22 pages (with references, tables, maps and graphics).

The article should be preceded by an abstract of 250-300 words (keywords between 4 and 7 words long).

Authors are also welcome to write a short professional biography (in 3-4 sentences).

The non-English titles should be written in original language.

The titles in Cyrillic alphabet should be written in original.
